ACADEMY REGISTRATION 2016-2017

Dear Parent/Dancer,

Every year the Academy registers with An Coimisiun Le Rince Gaelacha (CLRG) the governing body of Irish Dance based in Dublin and RTME in Europe. This allows the Academy to take part in all events organised by CLRG and RTME. CLRG also provides support and advice to their members and dancers, which includes a detailed child protection policy and training. To be a member of CLRG, each year the Academy pays an annual registration fee. This registration fee is payable for all of our registered teachers and adjudicators.

In addition to the Academy’s annual subscription to CLRG, the Academy covers itself with Public Liability Insurance and all teachers hold an Enhanced Disclosure Notice.

Every year the Academy passes this levy down through its members by way of an annual registration fee. Every dancer must be registered by the 1st August 2016 to be allowed to attend classes. Should a dancer join the class after this date a registration fee will still be applicable but may be adjusted to suit how long of the registration period remains.

Whilst the Academy provides full supervision of its dancers during classes it should be noted that the Academy does operate a “Working Alone with Children Policy” which means that due to the nature of some venues dancers may need to leave a class venue to go to the bathroom unsupervised.

The Academy does not allow parental attendance during classes but it is happy for parents to wait outside for the duration of lessons.

From time to time the Academy does take photos and videos of displays and/or lessons for publicity purposes only, and your registration gives the Academy full rights to use these images for this purpose without further consultation.

The Academy also operates a no paper policy which means all correspondence will be issued via email including Feis Syllabi, timetables, class fees and various fundraising events. Each dancer will also be requested to register with the member’s only area of the Academy website - www.mcgahanlees.com

This year the Academy will continue with a class T Shirt policy in all of its lessons. This is to ensure that all of our members are clearly identifiable, especially when we hire multi use venues. It also gives the school an identity at class and open competitions. In addition to the T Shirt (the cost of which is included within the registration fee), each dancer will obtain a shoe bag. This year will be in a new colour and design featuring our 20th Anniversary logo.

The registration fee will be at £25.00 per dancer. Families of 2 or more at £20 per person. ALL DANCERS (including ALL Adult Students) within the Academy are required to pay this fee.

This fee must be paid by 1st August 2016 at the VERY latest, thank you.
